The Government of Romania has received financing from the World Bank toward the cost of the Safer, Inclusive and Sustainable Schools Project (SISSP) and intends to apply part of the proceeds toward payments under the contract for Procurement of Temporary Facilities - mobile classrooms for students.
2. The Ministry of Education (MoE) through School and University Network Modernization Project Management Unit (SUNMPMU) now invites sealed Bids from eligible Bidders for mobile classrooms for students to be delivered and installed in the locations provided by the local authorities, in order to relocate the students during the execution of works for the schools included in the Project.
3. Bidding will be conducted through **national competitive procurement** using a Request for Bids (RFB) as specified in the World Bank's "Procurement Regulations for IPF Borrowers" dated July 2016, revised November 2017 and August 2018 and November 2020. ("Procurement Regulations") and is open to all eligible Bidders as defined in the Procurement Regulations.

5. The bidding document in English language may be obtained by interested Bidders upon the submission of a written application to the address below. The document may be downloaded from the link that will be submitted to the interested bidders.
6. Bids must be delivered to the address below on or before **4<sup>th</sup> of October 2023, 10:00 hours, Bucharest local time**. Electronic Bidding will not be permitted. Late Bids will be rejected. Bids will be publicly opened in the presence of the Bidders' designated representatives and anyone who chooses to attend at the address below on **4<sup>th</sup> of October 2023, 10:00 hours**.
7. All Bids must be accompanied by a *Bid Security* of 130,000 USD or an equivalent amount in Romanian Lei of 600.000.
8. Attention is drawn to the Procurement Regulations requiring the Borrower to disclose information on the successful bidder's beneficial ownership, as part of the Contract Award Notice, using the Beneficial Ownership Disclosure Form as included in the bidding document.
