1	Shortlisting criteria is "availability of core personnel to execute the project" while the interested companies must provide "list of key specialized personnel".  Could you please clarify if "core personnel" and "key specialized personnel" refers only to the fully employed permanent staff or also to the "experts on other collaboration contracts".	The core personnel / key specialized personnel can be experts on other collaboration contracts.
2	Our understanding is that the Key Experts will not be evaluated at the shortlisting stage. However, do we have to provide a list of potential Experts that we are planning to involve in the project activities?	As stated in the REOI,  () Key Experts will not be evaluated at the shortlisting stage.  However, in this stage the consultant must provide a list of key specialized personnel that the consultant intends to involve in contract implementation.
3	Besides similar finalized assignments and support documents, can we present ongoing similar assignments (contract and interim reports are available)?	In evaluation process will be considered the similar projects accompanied by documents showing the <u>fulfillment of contractual obligations</u> , acceptance report, other relevant documents in support of the requirement.
4	We understand that "experience in investment planning" is related to both works and equipment. Please confirm.	Considering the specifics of the assignment, the experience must be related to works.
5	For "capacity to manage large research projects" we understand that "large research projects" are both Technical Assistance projects including activities related to technical data collection and analysis as well as survey research type of projects. Please confirm.	We confirm your understanding.
6	Can we send the necessary documents mentioned to be submitted in Romanian or is an authorized English translation necessary?	All documents must be provided in English.
